

Technical bid (Envelope – ‘A’) and Financial bid (Envelope ‘B’) (Envelope ‘A’ and ‘B’ with the content shall be clearly marked on the top of the envelopes separately). Technical Part – Bids (Envelope – ‘A’) shall comprise of compliance documents Qualification Requirement, IT Return copy, GST certificates, company profile and any other document in support of technical capability. The Technical bid should not contain any financial indication, violation of which will invite disqualification. Financial bid shall comprise of quoted price only in the format provided with the tender document.

Completed Separate tenders against each of the two (Technical part in one envelope, Financial part in another envelope, and the two envelopes put into one third envelope, with all envelopes superscribed about Name of Work and contents, envelope type whether ‘A’ or ‘B’) should be submitted to the Receiving Cell of IEI by **15 March 2024**.

All pages of the tender document including tender notice are to be signed by the bidders. IEI reserves the right to reject the tender in full or part without assigning any reason.

ANNUAL CONTRACT FOR AC CAR HIRING CHARGES

QUALIFICATION REQUIREMENT

1. The Agency must have executed such services during the last three years starting from 2020-2021 till date.
2. The Annual Average Turnover must be Rs.10 lakhs onwards.
3. List of clients during last 3 years and related work order.
4. Earnest Money Deposit (EMD) of Rs.5000/- to be deposited along with tender document through DD/Cheque in favour of “The Institution of Engineers (India)” payable at Kolkata.

OTHER TERMS & CONDITIONS

- i) Conditions of the vehicles:** The vehicles must be in good running and clean/sanitized condition. IEI reserves the right to refuse vehicles of inferior conditions, if supplied. The drivers should maintain cleanliness. AC in all vehicles should be in good running condition.
- ii) Guarantee of supply:** The supplier will be duty bound to supply vehicle as per order within 24 hours of receipt of booking intimation or as and when required on urgent basis. In case of failure to supply the vehicle, IEI will book transport from other agencies and the additional expenditure, if any, incurred by IEI will be realized from the supplier. Repeated failure of vehicle supply will result in cancellation of the order.
- iii) Garage Distance:** Maximum distance of 1 kilometer and 15 minutes should be admissible for garage in/out vehicle from IEI HQ at 8 Gokhale Road., Kolkata 700020.
- iv) Compliance of MV Act & Rules:** The supplier shall ensure that the deployment of the vehicles comply with existing MV Act & Rules of the Government and the driver should carry the valid Driving Licence and necessary documents so that the user is not harassed by the enforcing Authorities while travelling in the hired vehicles.
- v) Payment Terms:** The supplier will submit monthly bills on the basis of hourly rate or KM run rates, whichever is higher subject to the condition of minimum hours of deployment charges. Car parking charges, entry fees and toll tax if any, at any place will be paid on actual as per certified receipts by the guest/user to be enclosed with the bills.

- vi) The place and time of releasing vehicle has to be noted in duty slip, duly signed by the guest/user availing the car.
- vii) EMD of the successful bidder shall be kept as Performance Guarantee and shall be refunded after expiry of contract without any interest. However, EMD of unsuccessful bidder shall be refunded without any interest.
- viii) The contract shall be valid for one year and the same may be renewed in case of satisfactory performance. However, the decision of IEI shall be final and binding in this regard.
