The sealed tenders are to be submitted duly stamped and signed and dated on each page of the tender document as their unconditional acceptance to the terms prescribed by the Institution. Details/supporting documents wherever applicable, if attached with the tender should be duly authenticated by the vendor/s. No over-writings shall be accepted unless authenticated with full signature of the vendor/s.

The tender shall be in two parts viz. **Technical Part – (Envelope – 'A')** and **Financial bids (Envelope 'B')** (Envelope 'A' and 'B' with the content shall be clearly marked on the top of the envelopes separately). **Technical Part (Envelope – 'A')** shall comprise of compliance documents against Qualification Requirement, company profile and any other document in support of technical capability. The Technical bid should not contain any financial indication, violation of which will invite disqualification. Financial bid shall comprise of quoted price only in the format provided with the tender document in **Envelope – 'B'.** Both Envelope – A & B shall be put in a third envelope, sealed and submitted within the prescribed date & time and with signature of the tender applicant over it.

The sealed tender duly superscribed, "Renewal of Subscription, Support & Services for FG-200E Unified Threat Management Device (UTM)" with Tender No. should be addressed to Deputy Director(NT/IT) sent at the Institution's address either by registered post/speed post or by hand. Postal / courier of the tender document must reach to this office within stipulated date & time i.e., upto16.00 hrs of 25 April 2024.

Tenders received after the stipulated date and time shall not be entertained. The Institution shall not be liable for any postal delays for what so ever reason and tender received after the stipulated time/date are liable to be rejected summarily without giving any reason and any correspondence.

Qualification Criteria

- 2. The bidder should have executed (during last 5 years) at least 5 such projects for implementation of UTM devise.
- 3. Bidder should have experience of implementing group wise bandwidth management for the users of an Active Directory though the UTM.
- 4. Bidder has to submit their clientele.
- 5. Bidder should be authorized partner / service provider of the UTM manufactures
- 6. The bidder must have single fully functional contact support centre with 24 X 7 support.
- 7. Bidder must ensure Single point of contact for troubleshooting or a helpdesk team will function as a single point of contact for all sorts of problem for this system.
- 8. Bidder have to assist Institution with proper support, if required, in case there is change in Internet connectivity.

Guidelines on Bid submission:

- 9. The language of the documentation & details in the Bids must be in English.
- 10. All bids to be submitted in single stage two envelope in separate covers:
 - i. <u>Technical Bid</u>: Envelope A should be superscribed with Tender No and Name of Job i.e."Renewal of Subscription, Support & Services for FG-200E Unified Threat Management Device (UTM)" and word "TECHNICAL BID" along with the duly signed and stamped photocopy of documents and signed by authorized representative:
 - a) Self certified copies of the audited balance sheet and profit & loss statement for the last 3 completed financial years
 - b) Copy of PAN Card
 - c) Copy of GST registration certificate
 - ii. <u>Financial Bid</u>: Envelope should be superscribed with Tender No and Name of Job i.e."Renewal of Subscription, Support & Services for FG-200E Unified Threat Management Device (UTM)" and word "FINANCIAL BID" containing rate coated by the party duly signed and stamped by authorized representative.

- 13. The contract shall be for one year and can be renewed on satisfactory performance. Rate during renewal should be mutually agreed. However, the decision of IEI should be full & final.
- 14. IEI reserves the right to reject any or all the quotations without assigning any reason whatsoever.
- 15. Vendor shall not subcontract the hardware maintenance jobs to any outside agency including their franchisee
- 16. Payment shall be made in advance on submission of invoice in original.

Scope of Work

- 17. The vendor must provide single fully functional contact support centre with 24 X 7 support.
- 18. The vendor must ensure Single point of contact for troubleshooting or a helpdesk team will function as a single point of contact for all sorts of problem for this system.
- 19. The vendor have to assist Institution with proper support, if required, in case there is change in Internet connectivity.
- 20. Vendor has to mention the Escalation procedure and matrix for customer complaints
- 21. Any fault in the UTM will need to be resolved by the vendor within 4 hours of fault booking.
- 22. In case of hardware failure the vendor has to provide a standby UTM device within 72 hours of diagnosis of problem as hardware fault.
- 23. If the problem not resolved within the 4 hours then penalty will be charged @ Rs 2000/per day to the Vendor. The same penalty will be applicable if a stand by UTM device is not
 provided in case of hardware failure.
- 24. Training to be provided by the vendors to the IEI personnel for performing day to day operation of the device.
- 25. The vendor has to provide onsite support, when required.
- 26. The vendor has to ensure one year full support.
- 27. The contract includes Preventive maintenance on a quarterly basis subject to our mutual convenience.
