Tender for E-Waste Management, Recycling & Certified Destruction

1. Invitation for Bids

The Institution of Engineers (India) (IEI) invites sealed tenders from eligible and Government-authorized e-waste recyclers for undertaking E-Waste Management, Recycling and Certified Destruction of identified obsolete electrical and electronic items, strictly in accordance with applicable Government regulations and terms set out herein.

2. Nature of Work

This tender relates exclusively to E-Waste Management & Certified Destruction, to be executed only through Central /State Pollution Control Board authorised recyclers.

3. Scope of Work

The successful bidder shall be responsible for the following:

1. Collection of identified electrical and electronic waste (e-waste) from IEI premises at 8, Gokhale Road, Kolkata - 700020.
2. Transportation of e-waste through authorized and compliant logistics arrangements.
3. Recycling, processing and/or destruction of e-waste strictly in compliance with:
 - E-Waste (Management) Rules, 2016 and other applicable Rules and Regulations
 - Guidelines issued by Central / State Pollution Control Board
4. Ensuring environmentally safe dismantling and recycling, without any adverse impact on health or environment.
5. Submission of the following mandatory certificates/documents as applicable after completion of disposal:
 - E-Waste Recycling Certificate
 - Certificate of Destruction / Recycling Completion
 - Weight-wise disposal statement of items processed
6. Ensuring that no item is resold, reused, refurbished, or diverted in any manner.
7. Submission of all certificates within 30 (thirty) working days from the date of lifting of materials.

4. Eligibility Criteria

The bidder must:

1. Be a legally registered company / firm.
2. Possess valid authorization from Central /State Pollution Control Board for recycling or processing of e-waste.
3. Have minimum 5 (five) years' experience in e-waste management and recycling.

4. Have an office and/or processing facility in or around Kolkata.
5. Have a minimum annual turnover of ₹ 20 lakh in any of the last three financial years.
6. Not be blacklisted by any Central / State Government / PSU / Autonomous body.

5. Earnest Money Deposit (EMD)

Selected bidder has to deposited applicable earnest money as applicable

- Amount: Rs.10,000/- (Rupees Ten Thousand only)
- Mode: Demand Draft in favour of “The Institution of Engineers (India)”, payable at Kolkata
- EMD shall be returned after submission and verification of destruction certificates.
- EMD shall be forfeited if the bidder fails to comply with lifting or certification timelines.

6. Payment Terms

1. 100% payment to be made in advance before lifting of e-waste items.
2. No credit facility shall be permitted.
3. All applicable taxes, duties and levies shall be borne by the bidder.

7. General Terms & Conditions

- Lifting of items shall be completed within 5 (five) days from issuance of work order.
- The work shall be carried out without disrupting normal activities of IEI.
- Any damage caused to IEI property shall be recoverable from the bidder.
- The bidder shall comply with all applicable safety norms and labour laws.
- IEI reserves the right to accept or reject any or all bids without assigning reasons.
- Jurisdiction: Kolkata only.
- Decision of IEI shall be final and binding.
