The Institution of Engineers (India) invites sealed Tenders from eligible bidder(s) in Single Stage two Envelope bid system for Renewal of AMC support services of IEI Managed Email Service using Google G-Suite under "ieindia.org" domain.

The sealed tenders are to be submitted duly stamped and signed and dated on each page of the tender document as their unconditional acceptance to the terms prescribed by the Institution. Details/supporting documents wherever applicable, if attached with the tender should be duly authenticated by the vendor/s. No over-writings shall be accepted unless authenticated with full signature of the vendor/s.

The tender shall be in two parts viz. **Technical Part – (Envelope – 'A')** and **Financial bids (Envelope 'B')** (Envelope 'A' and 'B' with the content shall be clearly marked on the top of the envelopes separately). **Technical Part (Envelope – 'A')** shall comprise of compliance documents against Qualification Requirement, company profile and any other document in support of technical capability. The Technical bid should not contain any financial indication, violation of which will invite disqualification. Financial bid shall comprise of quoted price only in the format provided with the tender document in **Envelope – 'B'.** Both Envelope – A & B shall be put in a third envelope, sealed and submitted within the prescribed date & time and with signature of the tender applicant over it.

The sealed tender duly superscribed, "Renewal of AMC support services of IEI Managed Email Service using Google G-Suite under "ieindia.org" domain" with Tender No. should be addressed to Deputy Director (IT & Admin) sent at the Institution's address either by registered post/speed post or by hand. Postal / courier of the tender document must reach to this office within stipulated date & time i.e., upto16.00 hrs of 20 Dec 2024.

Tenders received after the stipulated date and time shall not be entertained. The Institution shall not be liable for any postal delays for what so ever reason and tender received after the stipulated time/date are liable to be rejected summarily without giving any reason and any correspondence.

Qualification Criteria

 - b) Copy of PAN Card
 - c) Copy of GST registration certificate

- 5. User management & trouble shooting in Google Admin Console.
- 6. Support and provide list of URL and port to be allowed in Firewall for smooth access of G Suite in IEI network.
- 7. G Suite Control Panel settings like routings, possible policies around emails etc.
- 8. Create and configure support for 2 Step verification for superadmins as per requirement.
- 9. Provide support to resolve the problem related to the email services.
- 10. To provide Interface with enriched Text/Graphics for browsing emails through the Internet.
- 11. To Provide Mailbox Control for managing mail boxes.
- 12. Vendor to provide required URLs and Ports to access G-Suite services in IEI Network
- 13. Setup Sender Policy Framework record for all primary and Secondary domain in G Suite as per requirement.
- 14. Setup DKIM record for all primary and Secondary domain in G Suite as per requirement
- 15. Full featured Google Admin Control Panel allowing IEI IT admin to manage all users, services, security policies and devices from one single location
